



CALL FOR NOMINATIONS FOR CIRIP GOVERNING COUNCIL ELECTIONS

Dear CIRIP Member,

Pursuant to sections 4 of the **Chartered Institute of Restructuring and Insolvency Practitioners, Ghana Act, 2024 (Act 1117)** do hereby open nominations for the following positions:

- **President – 1**
- **Vice President – 1**
- **Council Members – 3** (at least one must be a woman)

Members are hereby invited to file their nominations and be endorsed by two members in good standing to the respective positions of the Governing Council.

Please note that the upcoming **Annual General Meeting (AGM)** of the Institute, scheduled for **Wednesday, 3rd December 2025**, will also serve as the election date for vacant positions on the **Governing Council**.

COUNCIL RESPONSIBILITIES (SECTION 5 OF ACT 1117)

The Council shall:

- a) **Exercise general oversight responsibility over**
 - i) the Institute; and
 - ii) the strategic direction of the Institute.
- b) Consider proposals for review of the terms and conditions of service of staff of the Institute submitted by the Chief Executive Officer.
- c) Ensure the effective and efficient performance of the functions of the Institute;
and
- d) Perform any other function that is ancillary to the object of the Institute.



Eligibility Criteria

Nominees must:

Be members of CIRIP in good standing.

Grounds for Disqualification (Act 1117, Section 18(2))

A person is **not qualified** to be registered or elected if that person has:

- Been convicted of an offence involving fraud or dishonesty.
- Been declared by a certified psychiatrist and adjudged by a court to be of unsound mind.
- Been convicted for high crime, high treason, treason or an offence involving the security of the State.
- Been adjudged insolvent or bankrupt and is not discharged.
- Been found guilty of professional misconduct by another professional body.
- Been disqualified under section 177 of the Companies Act, 2019 (Act 992).

Nomination Guidelines

- Each nomination must be **endorsed by two (2) members in good standing**.
- Members may submit **up to two (2) nominations per position**.
- **Deadline for nominations: Tuesday, 25th November 2025.**
- Names of all nominees will be published by the **Nominations Committee** after the deadline.
- Shortlisted candidates will be announced by **Friday, 28th November 2025.**



Please note:

- All current Council members are eligible for re-election
- Voting will take place during the AGM by ballot or electronic means as determined by the Council in accordance with section 7 of the third schedule of the CIRIP Act 1117.
